CREATING Initiative Launches Regulatory Training at Duke Kunshan University, China

The CREATING Initiative has marked an important milestone in its efforts to build regulatory capacity, for in-vitro diagnostics (IVD) companies across Asia with the launch of its first Functional Training titled, "Regulatory Frameworks and Requirements for IVD", held from 10-12 November, 2025.

Commissioned by the Gates Foundation, the training was jointly organised with **Duke Kunshan University** and designed specifically for regulatory professionals of IVD manufacturers based in Asia.

Regulatory capacity building is a key component for the success of innovative and quality IVD's to reach global markets. Responding to this need, a three-day bespoke workshop, brought together 34 participants which included professionals from China and Korea.



The workshop introduced participants to Duke-NUS team-based learning approach grounded in diverse expertise, shared problem-solving, and real-world application, with the mission to strengthen the ability of IVD manufacturers to navigate complex regulatory pathways and reach global markets.

The Functional Training was facilitated by CoRE's faculty led by Asst/Prof James Leong, Head of the Health Products and Regulatory Science, and Asst/Prof Wei Chuen Tan-Koi, Lead of Regulatory Systems Strengthening.

The course was enriched by insights from experts at the Singapore's Health Sciences Authority, the World Health Organisation's Prequalification IVD Assessment Team, Professor Yao Chen from Peking University First Hospital, and the team from DH RegSys, including co-founders Ms Hwee Ee Tan and Mr Andrew Ho who brought together more than 50 years of regulatory and industry experience.

Grounded in real-world case studies, participants engaged in interactive case discussions and applied the newly acquired regulatory skills in creating their own regulatory filing strategy.
